

**NOTICE OF GENERAL MUNICIPAL ELECTION
OAK GROVE R-VI SCHOOL DISTRICT
OF JACKSON COUNTY, MISSOURI
TUESDAY, APRIL 7, 2020**

Notice is hereby given to the registered qualified voters of Oak Grove R-VI School District of Jackson County, Missouri, that the Board of Education of said School District has called a General Municipal Election to be held on Tuesday, April 7, 2020. *In accordance with Missouri Governor Michael L. Parson's Executive Order 20-03 dated March 13, 2020, the April 7, 2020 General Municipal Election was officially rescheduled to June 2, 2020.* The polls will be open from 6 a.m. until 7 p.m.

The Jackson County Board of Election Commissioners will conduct the election in that part of the School District within Jackson County; the Clerk of the Lafayette County Commission will conduct the election in that part of the School District within Lafayette County; and the Clerk of the Johnson County Commission will conduct the election in that part of the School District within Johnson County.

Shall the Board of Education of the Oak Grove R-VI School District, Missouri, borrow money in the amount of Twenty Two Million Five Hundred Thousand Dollars (\$22,500,000.00) resulting in no estimated increase to the debt service property tax levy for the purpose of providing funds for the implementation of safety and security measures; upgrades to technology; renovations to the Elementary School; the site development, construction, equipping, and furnishing of classroom additions; repair and replacement of roofs and heating, ventilation, and air conditioning (HVAC) systems; to the extent funds are available, completion of other repairs and improvements to existing facilities of the district; and issue general obligation bonds for the payment thereof?

If this proposition is approved, the adjusted debt service levy of the School District is estimated to remain unchanged at \$1.6123 per one hundred dollars of assessed valuation of real and personal property.

NOTICE OF ACCESSIBILITY

FURTHER NOTICE IS GIVEN that, where a regular polling place has limited accessibility, a disabled or elderly voter may be provided an alternative means of casting his or her ballot. Such means may include reassignment to an accessible polling place, curbside voting, assisted voting or voting by absentee ballot. A voter may apply for an absentee ballot in person or by mail, or may have a relative or guardian apply in person on his or her behalf. If an absentee voter is disabled or incapacitated, the notary requirement is waived. In addition, voters requiring assistance may be assisted by a person of the voter's choice.
