

**NOTICE OF GENERAL MUNICIPAL ELECTION
REORGANIZED SCHOOL DISTRICT NO. 7
OF JACKSON COUNTY, MISSOURI
TUESDAY, APRIL 7, 2020**

Notice is hereby given to the registered qualified voters of Reorganized School District No. 7 of Jackson County, Missouri, that the Board of Education of said School District has called a General Municipal Election to be held on Tuesday, April 7, 2020. *In accordance with Missouri Governor Michael L. Parson's Executive Order 20-03 dated March 13, 2020, the April 7, 2020 General Municipal Election was officially rescheduled to June 2, 2020.* The polls will be open from 6 a.m. until 7 p.m.

The Jackson County Board of Election Commissioners will conduct the election in that part of the School District within Jackson County; the Kansas City Board of Election Commissioners will conduct the election in that part of the School District within the corporate limits of Kansas City; and the Clerk of the Cass County Commission will conduct the election in that part of the School District within Cass County.

Shall Reorganized School District No. 7 of Jackson County, Missouri (Lee's Summit) issue its general obligation bonds in the amount of \$224,000,000, resulting in no estimated increase to the debt service levy, for the purpose of acquiring property and constructing, renovating, improving, furnishing and equipping school sites and facilities, including:

- **installing safety and security improvements throughout the District**
- **constructing a new middle school**
- **constructing an addition to and renovating Lee's Summit High School**
- **renovating Pleasant Lee Middle School, Bernard Campbell Middle School and Summit Lakes Middle School**
- **constructing an addition to and renovating Mason Elementary School**
- **renovating a portion of Prairie View Elementary School for early childhood education**
- **making improvements to the District's High School athletic/activities facilities and stadiums?**

If this question is approved, the District's debt service levy is estimated to remain unchanged at \$1.07 per one hundred dollars assessed valuation of real and personal property.

NOTICE OF ACCESSIBILITY

FURTHER NOTICE IS GIVEN that, where a regular polling place has limited accessibility, a disabled or elderly voter may be provided an alternative means of casting his or her ballot. Such means may include reassignment to an accessible polling place, curbside voting, assisted voting or voting by absentee ballot. A voter may apply for an absentee ballot in person or by mail, or may have a relative or guardian apply in person on his or her behalf. If an absentee voter is disabled or incapacitated, the notary requirement is waived. In addition, voters requiring assistance may be assisted by a person of the voter's choice.
